MONTGOMERY COUNTY LADIES OPEN TOURNAMENT RULES

1. Entry to this tournament is open to all USBC female members. Non-members may also qualify for entry and all USBC services by paying an Affiliate Membership Fee of \$19.00 or a Participation Fee of \$5.00 prior to bowling.
2. Entrants are eligible to receive only one prize, that being the highest in the scratch or handicap division.
3. Entrants are automatically entered in both scratch and handicap divisions. Bowlers will be placed in the highest qualifying division. If bowler qualifies in an equal position in both divisions, they will be placed in the scratch division.
4. Report and use averages from USBC leagues only. Use highest USBC certified average based on a minimum of 21 games for 2018-19 winter or summer season or, if no 2018-19 average, use 2017-18 certified average. If no average for 2017-18 or 2018-19, use highest current USBC certified average, 21 games or more as of March 1, 2020. An entrant, who has no average meeting the above requirements, must enter using a 210 average. Handicap is 80% of 210 average; maximum handicap is 64 pins per games.

If a bowler's current average for 21 or more games is 10 or more pins higher than last season's average as of March 1, 2020, current average must be used (USBC Rule 319a 2). It shall be each bowler's responsibility to verify the accuracy of the reported average on the entry form. Failure to use proper average or make corrections prior to completion of the first game shall disqualify score if submitted average is lower than actual average thereby resulting in higher handicap. If the submitted average is higher than previously reported average, prize winnings will be based on the submitted average (See USBC Rule 319a. 3 for further clarification). Bowlers from outside the Reading-Pottstown and Southeast USBC Associations MUST submit proof of average before the end of the qualifying round.

5. Entrants who were paid a prize of \$300 or more in any event in a tournament or paid a total combined prize winnings of \$500 or more in any one tournament or paid a total combined prize winning of \$1000 or more in all tournaments within the 12-month period prior to bowling in this tournament must report their actual scores; position and amount won to the tournament director for possible re-rating. (See USBC Rule 319d. for further clarification). The average adjustment rule will not apply (Rule 319e.2).
6. It is each bowler's responsibility to verify the accuracy of their own average and handicap whether originally submitted by the bowler or others. Failure to use the correct average and/or handicap may disqualify their scores if submitted average is lower than correct average or their handicap is incorrect. Prize winnings will be based on the submitted average, if it is higher than the correct average (Rule 319a-3).
7. The tournament directors reserve the right to re-rate any entrant prior to bowling for reasons other than those set forth in Rule 5.
8. Prizes will be paid on a ratio of at least 1 in 4, option prize ratio of at least 1 in 20.
9. USBC rules will govern.
